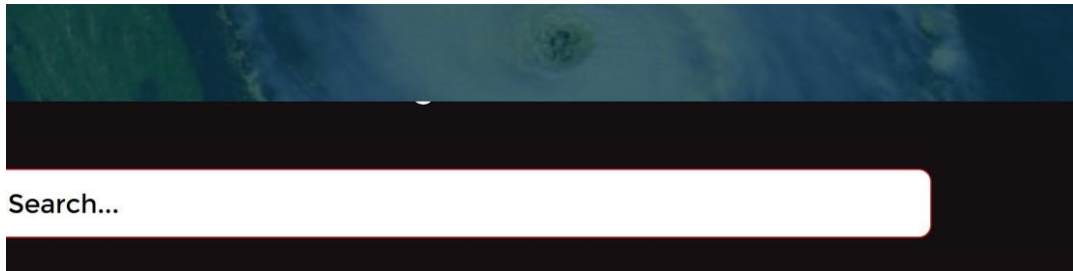

2. Click on 'Legislative Appropriation Program.'



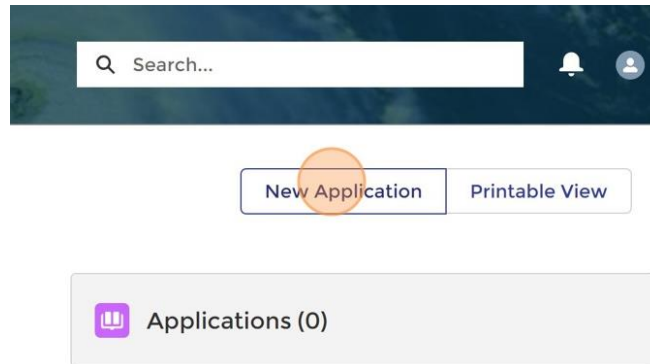

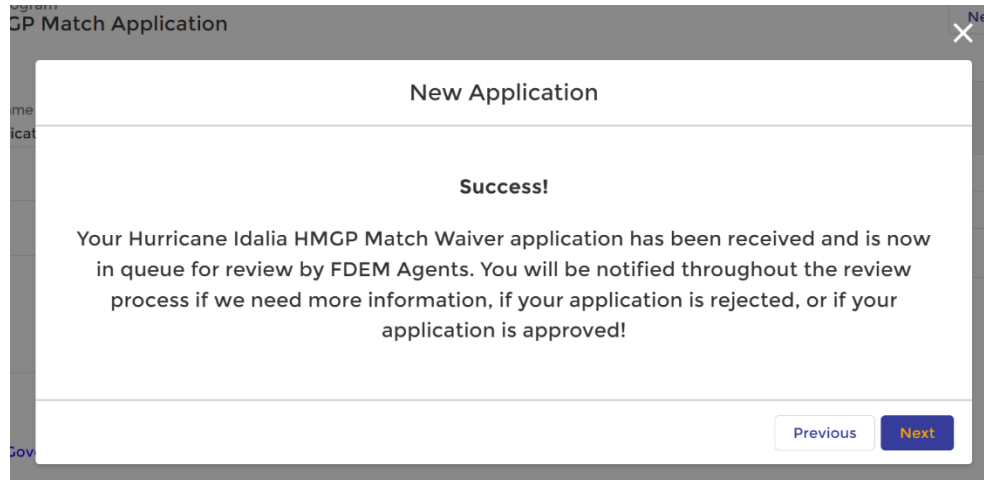

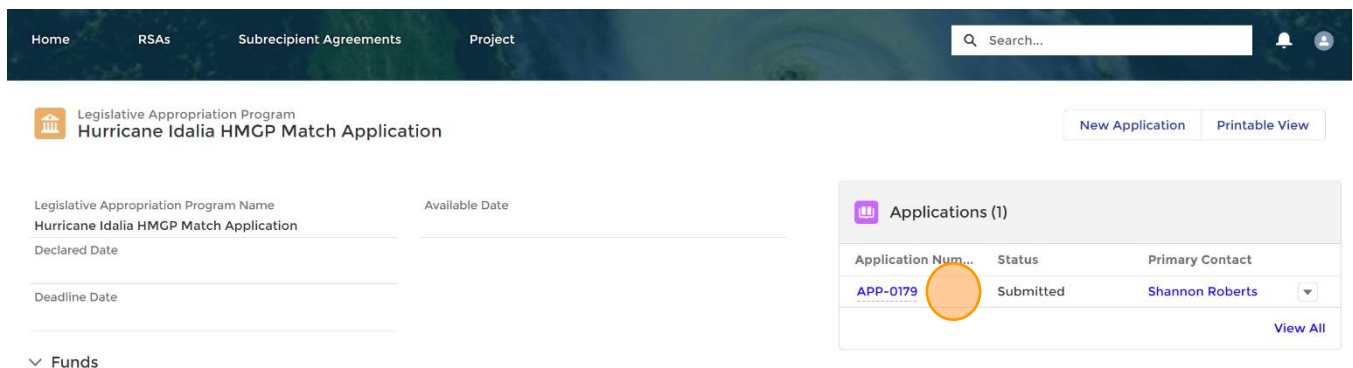
